- Evidence of Pension Compliance Certificate valid till 31st December, 2022;
- Evidence of Industrial Training Fund (ITF) Compliance Certificate valid till 31st December.
- Evidence of Nigeria Social Insurance Trust Fund (NSITF) Compliance Certificate valid till 31st December, 2022;
- Evidence of Registration on the National Database of Federal Contractors, Consultants and Service Providers by submission of Interim Registration Report (IRR) expiring on 30/06/2022 or valid Certificate issued by the BPP;
- Sworn Affidavit:
 - disclosing whether or not any officer of the relevant committees of the Centre for Management Development (CMD) or the Bureau of Public Procurement (BPP) is a former

or present Director, shareholder or has any pecuniary interest in the bidder and to confirm that all information presented in its bid are true and correct in all particulars;

- i. Reference Letters from a reputable Commercial Bank in Nigeria, indicating willingness to provide credit facility for the execution of the project when needed;
- j. Company Profile with the Curriculum Vitae of Key Staff to be deployed for the Project, including copies of their Academic/Professional qualifications
- Verifiable documentary evidence of at least Three (3) similar Jobs executed in the last Five (5) years including copies of Letters of Award, Valuation Certificates, Job Completion Certificate and photographs of the projects;
- For Training Programme: Evidence of Firm's Accreditation/Registration with the Centre for Management Development (CMD);
